USAFL 2025 Season Disciplinary Report

October 31, 2025

There is precedent and common practice in Amateur Football Leagues in Australia to publish a public disciplinary report. The intent is to provide USAFL Clubs visibility about the on-field incidents and disciplinary outcomes in USAFL tournaments and games.

To elevate the visibility of the disciplinary process in the USAFL and to highlight the consequences for infractions, after all major tournaments, all disciplinary reports (including on field and off field) will be:

- Publicly posted on the USAFL website: aussierulesusa.com
- Digitally recorded in PlayHQ. These records will remain permanently tied to a player's history.

Player History is not limited to only a single tournament. Player History refers to the complete career timeline of a player. The introduction of this public report will help keep all accountable for their own actions and act as a deterrent to future infractions for all clubs and individuals within the USAFL.

Penalties will be enforced and tracked within PlayHQ for players in accordance with USAFL policies. Eligibility for suspended players will be managed through PlayHQ, ensuring transparency and consistency. Penalties will apply to all 'Club' level games, 'USAFL Sanctioned' games, and USAFL 'Tournament' games. They will not apply to 'Rec' level activities. This means that if an individual receives a suspension of 'x' games, they will need to sit out the designated number of 'Club', 'USAFL Sanctioned', or 'Tournament' games before they can actively participate again.
